Minutes of the Previous Governing Body

Dr. A. George Louis Raja read the minutes and Rev. Fr. Principal presented the

Action Taken Report of the previous Governing Body meeting held on

30/08/2019. Both the minutes and Action Taken Reports were passed without

any corrections.

Minutes of the Finance Committee

Rev. Dr. G. Theophil Anand, Vice Principal (Admin.) Shift-II read the minutes of

the Finance Committee meeting held on 12/12/2020. It was recommended by

Rev. Dr. Arockiasamy Xavier, SJ to record the non-receipt of Autonomy Grant for

the academic year 2019-2020 in the minutes of the finance committee meeting.

Also, it was pointed out to change the term B.Sc., Counselling Psychology as B.Sc., Psychology.

With the above amendments the minutes of the Finance Committee was passed by the Governing Body.

Minutes of the 36th Ordinary Meeting of the Academic Council

Rev. Dr. Praveen Peter SDB, Vice Principal (Admin.) Shift-I & Controller of Examinations read the minutes of the 36th Ordinary Meeting of the Academic Council. It was suggested to correct the expansion for the acronym SHYIA as Sacred Heart Young Innovator Award. With the above correction the minutes of the 36th Ordinary Meeting of the Academic Council was passed by the Governing Body.

Minutes of the Curriculum Development Cell (CDC) Meetings

Rev. Dr. D. Maria Antony Raj SDB, the Principal presented the minutes of the Curriculum Development Cell Meetings held on 04/08/2020, 02/09/2020, 11/09/2020, 04/11/2020, 28/11/2020 and 04/12/2020.

The following corrections were made in the above meetings:

The statement "The M.Phil., scholars who have arrears and have applied for the examination can be declared pass as per guidelines from the Government" found in the minutes of the meeting held on 02/09/2020 has to be removed.

In the minutes of the meeting held on 04/12/2020 the entry (5 out of 2 Questions) found in both UG and PG question paper pattern should be corrected as (2 out of 5 Questions).

With the above amendments the minutes of the Curriculum Development cell meetings held on 04/08/2020, 02/09/2020, 11/09/2020, 04/11/2020, 28/11/2020 and 04/12/2020 were passed by the Governing Body.

Rev. Dr. D. Maria Antony Raj SDB, the Principal briefed about the conduct of April 2020 Examinations in Online mode. He explained about the indigenously tailored software which had provisions to upload the question papers and answer scripts, invigilation and evaluation. He further stated that as per Government regulations the students without internet access were allowed to appear for the examination in the campus.

Dr. A. Liyakath Ali, Member-Syndicate, Thiruvalluvar University highly appreciated the efforts of the college in the conduct of online examinations and also appreciated the support of Sacred Heart College in automating the preparation of Seniority List of Faculty members in the affiliated colleges of Thiruvalluvar University.

Rev. Dr. Arockiasamy Xavier, SJ also acknowledged this initiative and suggested to get a Letter of appreciation from Thiruvalluvar University and to upload it in the official website of the college.

Admissions

Rev. Dr. D. Maria Antony Raj SDB, the Principal presented the admission statistics. He informed that seats in all the Undergraduate programmes are full except for B.A. (History). He also stated that seats in most of the Postgraduate courses are also full, although vacancies are there in M.Sc., (Biochemistry), M.Com., M.A (Tamil and Economics) programmes. Due to change of policy by UGC and also delayed permission granted by the university, the M.Phil admission have dipped.

Rev. Dr. John Alexander SDB, the Rector and Secretary suggested including the admission data of Adi Dravidar Christians.

Results

Rev. Dr. Praveen Peter SDB, the Controller of Examinations presented the results of April 2020 examinations and also the April 2020 arrear examinations results for ratification.

Scholarships and Research Grants

Rev. Dr. D. Maria Antony Raj SDB, the Principal briefed on various scholarships provided to the students. He noted that there is a dedicated desk in the college office which handles solely the student scholarships. He was happy to place on record that Rs. 2.41 Crore worth of scholarships was received through various Government/Non-Government scholarship schemes and Rs. 2.39 Crore has been disbursed to the students. He also highlighted about the Management scholarship worth Rs.35 Lakhs, Mid-day meal scheme worth Rs. 5.33 Lakhs and IVDP scholarship for orphan/semi-orphan students for 6 Lakhs.

It was suggested by Rev. Dr. K.A. Maria Arokiaraj, Additional Principal to include the matching grant in student contributory scholarship.

Rev. Dr. D. Maria Antony Raj SDB, Principal further briefed about the research grants instituted by the management for students and faculty.

Details of Left Students

Rev. Fr. Principal presented the list of students discontinued the courses on personal reasons.

Supporting the education of children of Domestic Staff

Rev. Fr. Principal mentioned that as per the guidelines by the Salesian Province of Chennai to support the education of children of domestic staff working in Salesian institutions, 75% of college fee will be waived for the children of domestic staff, 50% for the children of management non-teaching staff, and 25% for the children of management teaching staff studying in sacred heart college. Further, he also mentioned that Rs.5000 will be provided for each of the children of domestic staff studying in other schools.

Annual Quality Assurance Report (AQAR)

Rev. Fr. Principal presented the AQAR for the academic year 2019-2020 and sought for the approval of the Governing Body. The Governing Body approved the AQAR of the academic year 2019-2020.

Autonomy Extension

Rev. Fr. Principal informed that the visit of the Autonomy Extension Committee is scheduled on 5^{th} and 6^{th} of February, 2021.

CIBI (Centre for Innovation and Business Incubation)

Rev. Dr. G. Theophil Anand, Vice Principal (Admin.) Shift-II briefed about the proposal to promote incubation in the campus called as CIBI. The members were very much appreciative about this initiative.

Endowments

Fr. Carreno Research Grant for Ph.D. Scholars

Rev. Fr. Principal noted that Fr. Carreno Research Grant for Ph.D. Scholars will be constituted to provide seed money to aid the research of Ph.D. scholars, in addition to existing grants.

Digitization of Administration

Rev.Fr.Principal mentioned about the new add-ons in the e-Administration of Sacred Heart College. He noted that admissions for the academic year 2019-2020 was done online. Provisions were made in the web portal for online submission of application, payment of application fee, certificate verification, payment of college fee and downloading of admit card. He also mentioned about the conduct of April & November-December 2020 examinations in online mode.

Outcome Based Education Syllabus

Rev. Fr. Principal informed that due to the National Education Policy (NEP) 2020, the revision of curriculum under OBE framework is put on hold, and once the clear guidelines are released by the Government, OBE framework will be implemented.

Rev.Fr.Principal informed that B.Sc., (Psychology), M.Sc., (Applied Micro biology), Postgraduate Diploma in Cyber Security and Postgraduate Diploma in Data Science courses will be started from next academic year 2021-2022.

Rev. Dr. Arockiasamy Xavier appreciated the efforts of the college and felt that
