The 28th ordinary meeting of the academic council began with a prayer lead by Rev. Fr. Rector.

Rev. Fr. Principal welcomed members and thanked all the member for their cooperation.

The members observed one minute silence as a mark of respect for the sudden demise of Dr. D. Lakshmanan, Chairman & Managing Trustee, Quality Management Institute, who had been an expert for 5 years.

Rev. Fr. Principal informed the members that autonomous status has been extended for another 5 years.

The Minutes of the previous Academic Council and the Action Taken Report were read out and the same were passed with a some clarification sought by Mr. J. Missiadass asking about the relevance of retaining external members who have been absent consecutively for many years. It was clarified that Dr. Bhusnan D. Sudhakar and Mr. E. Srinivas had gone on a project mission. Hence they were absent.

Department of Value Education

Rev. Fr. Rector readout the minutes of the Standing Committee of BOS and was passed without any comments.

Department of Tamil

Dr. K. Parthibaraja presented the minutes of the BOS (UG). The difference between Sirappu Padam - Page No.37 and Viruppa padam page no.39 was explained Dr. L. Ravi suggested that subject experts should be included while framing syllabus for subjects other than the subjects of specialist departments for example syllabus of C Program.

Dr. A.J. Christopher intervened that C Program of the Computer Science and Physics department is different. There is qualified staff in the department of Physics itself. Therefore there was no need for including subject experts from the department of Computer Science.

Dr. P. Selvakumar readout the minutes of the Standing Committee of BOS in Tamil (PG) and was passed without any comments.

Department of English

Department of Commerce (UG)
