MEMORANDUM OF UNDERSTANDING



And



6. They will conduct joint certificate course as and when the need arises, as per mutual agreement.


IV. Terms of Agreement:

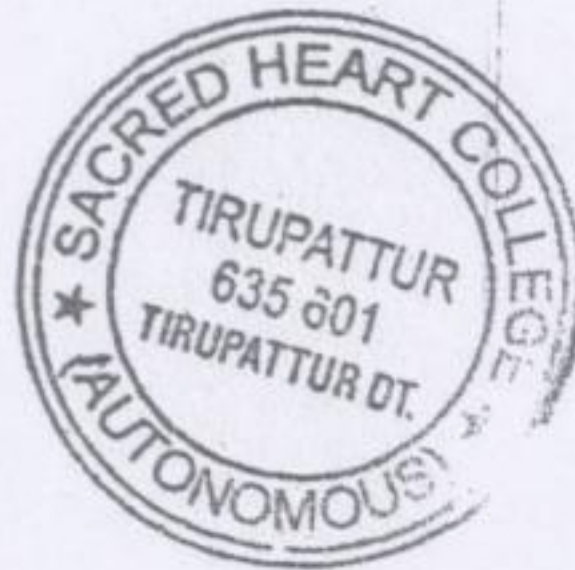


