- 3. The fee of Rs. 570/- should be remitted through NEFT/RTGS mode in the Indian Overseas Bank, IFSC Code: IOBA0002484, MICR Code: 632020014, Account Number: 248401000000001 and the original bank challan with UTR number should be enclosed with the application form.
- 4. Postal Order / Money Order / Demand Draft will not be accepted.
- 5. THE FOLLOWING DOCUMENTS SHOULD BE ENCLOSED FAILING WHICH THE APPLICATION IS LIABLE TO BE REJECTED.
 - a) M.Phil. Registration filled in application Signed by Principal and Supervisor.

 (In case of Part-Time candidate signature of the Head of the Institution where candidate is working)
 - b) PG Certificates (Provisional / Degree certificate). (Photocopy with Self attested)
 - c) PG Degree All Mark Statements. (Photocopy with Self attested)
 - d) Eligibility certificate in case of other University Students. (Original)
 - e) The Departmental approval order. (Photocopy)
 - f) Service Certificate issued by the Employer, Head Master / Principal / Head of the Institution (in the case of candidates applying for part-time Programme, specifying the total duration of the service put in by the candidates in their organization). (Original)
