Experts recommended the department to offer Social Entrepreneurship and Environmental Social Work as two papers **instead of Tourism & Management and Gender Studies**. Since Tourism & Management and Gender Studies are not relevant papers to be learnt by social work students the department can offer **Social Entrepreneurship and Environmental Social Work**.

Inculcation of the Study Tour for II MSW Students.

Dr. S. Paul Raj presented to the board the difficulties, challenges and hiccups faced in the conduct of the study tour. Various challenges included the availing of the necessary approval and acceptance from the Joint Directorate of Collegiate Education, compulsory requirement of a female faculty for every 15 female students, legal issues and necessities in availing due permission in time etc.

Rev. Fr. Ambrose stated that the Study Tour enriched the experience of the students as most of them were from a rural area and the tour gave them an opportunity to enrich their exposure.

Dr. Selvam denoted the fact that the Study Tour could be inculcated based on the various specializations offered by the department (HR, CD and YD).

Ms. Lisa addressed the gathering on the purpose of the study tour. She stated that many organizations and agencies only presented what was already available on their respective websites to the students. This did not bring about any significant learning changes amoung the students.

Fr. Andrews Raj stressed the fact that students should identify agencies by themselves, plan the respective schedule and present same to the department before undertaking the same.

Dr. S. Paul Raj also stated that he had studied the same with how neighboring colleges and universities inculcated the same programme. He also denoted to the gathering that the term 'Study Tour' could be changed to 'Field Trip' based on each specialization.

Based on the suggestions and recommendations given by the experts the Department has reworked the syllabus and sent it Academic Council for final Approval.

The following recommendations were suggested by Dr. J.M. Arul Kamaraj, University Nominee, Loyola College and Dr. Jonas Richard, Subject Expert, kristhu Jyothi College, Bangalore.

For M.Phil

1. Field Practicum for minimum 15 days based on their thesis can be included

2. Students should participate at least in one conference and present a paper

For MSW

1. References for each subject can be updated with recently published Books.

2. Three electives should be given and students can choose two electives on the first come first serve basis

3. In Field Work, Agency Supervisors feedback and minimum 10 marks from the supervisor can be included as internal components.

4. CA Components can be changed as the following,

CA Test- 10 Marks

Assignment – 5 Marks

Snap Test – 5 Marks (minimum 2 tests)

Library -5 marks (60 hrs to be completed for each semester and students should submit their work done for each subject)

5. Conducting Theory exams for Skill Paper for three hours doesn't exhibit their skill so department can adopt practice oriented exam pattern. Pattern can be introduced as 60 for Practical and 40 for CA

CA Components for 40 marks:

10 Mark- Assignments10 Mark- Test20 Mark- Work Book Assignments

Components for 60 Marks:

Practical Exam will be conducted for each skill paper and it may vary for each paper based on the syllabus. For example, mock Interview for Employability Skills, Group Discussion for Communication Skills
