Dr.A.George Louis Raja, the meeting secretary then read out the action taken report of the meeting. Conduct of Self-Study Courses

Rev.Dr.Praveen Peter SDB, the Controller of Examinations, mentioned that at present with regard to the self-study courses, the departments are internally setting the question papers, conduct the examinations, value the answer scripts and forward the credits to the controller of examination.

Rev.Dr.D.Maria Antony Raj SDB, the principal mentioned that the self-study courses are offered for advanced learners and like other courses, the students enrolled for self-study courses can also apply for the examination and pay the examination fee to the controller of examinations. This would confirm transparency in remunerating the faculty for the setting of question papers and evaluation for the self-study courses.

The controller of examination sought for a clarification on the handling of classes under self-study mode, and got clarified by the Chairman of the academic council that self-study courses doesn't require regular contact classes. Rev.Dr.D.Maria Antony Raj SDB, the Principal mentioned that establishing a Center for Certificate Courses is under consideration.

Change of Question Paper pattern for the January' 2022 Examinations

Rev.Dr.D.Maria Antony Raj SDB, the chairman presented to the board that due to the unprecedented situation caused due to the pandemic, the question paper pattern can be modified only for the upcoming January, 2022 examinations. He proposed the following changes:

Section – A, earlier had no choices, now it is proposed to include 2 or 3 choices.

Section – B, earlier had either or type of choices, which could be now converted to open type of choices.

Section – C can remain unchanged.

After discussion, the change in the question paper pattern for the January 2022 semester examination was approved by the members of the academic council.

Dr.L.Ravi suggested to ensure that a Faculty would chair only a single board (either UG or PG), and the chairman of the academic council responded that, appointing a single chairman for both UG and PG boards is an ad-hoc arrangement for the Fledgling departments, and mentioned that such appointments will be gradually withdrawn as the departments grow.

Remarks by the External Members

Dr.F.Sagayaraj Francis queried if there is any passing minimum in the internal component, and Rev.Dr.D.Maria Antony Raj SDB, chairman of the academic council responded that there is no passing minimum for internal component. He also wanted to know if the value added courses are considered for the calculation of CGPA, and Rev.Dr.D.Maria Antony Raj SDB, chairman of the academic council replied that they are not included for the CGPA calculation.

He highly appreciated the plan by the management to initiate a centre for certificate courses. He suggested that guidelines should be evolved to map the grades provided by MOOC agencies to the credits allotted by the college. The chairman of the academic council replied that the guidelines would be drafted at the earliest.

Dr.Bhusan D.Sudhakar also acknowledged the proposal to start the centre for certificate courses. He also suggested including more weightage for multiple choice question based evaluation, and added that the standard of the MCQs should be at par with questions set by national level testing agencies such as NET.

He enquired about the application of MOODLE in teaching and learning. Rev.Dr.D.Maria Antony Raj SDB, the chairman of the academic council explained that the college has adopted MOODLE as its official Learning Management System (LMS). The department of computer science started the usage of MOODLE in the year 2001, and later it was extended to all the departments from 2017 onwards. The college had provided hands-on training to the faculty from AIACHI, DBHEI and affiliated colleges of Thiruvalluvar University.

Dr.Charles Lasarado SJ appreciated the efforts of the college in the usage of MOODLE in teaching and learning. He further added that there is a clause in the National Educational Policy to offer 40% of a course content in off campus mode, which can make the college to reach out to more audience, and suggested that the college can implement this in the future.

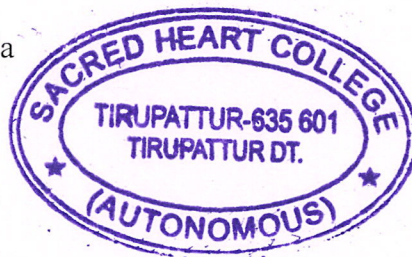

Briefing by the chairman about the presentations by various Board of Studies

Rev.Dr.D.Maria Antony Raj SDB, the Principal and Chairman of the Academic Council briefed that the Curriculum Development Cell and IQAC of the college has drafted the programme outcomes for UG and PG programmes. Based on which the Board of Studies of various departments were directed to draft their programme specific outcomes and courses outcomes, which will be presented for the approval of the academic council. The mapping of programme outcomes, programme specific outcomes and course outcomes will be presented in the next academic council meeting. Then the chairman announced the order of the presentation and invited the chairman of the respective boards to present the minutes of their board meetings along with the Programme Specific Outcomes and Course Outcomes of their respective Curriculum.

Presentations by various boards of studies

Department of Life Education

Rev.Dr. John Alexander, the chairman presented the minutes of the meeting of the board of studies in Life Education and the Programme Specific Outcomes and Course Outcomes of the curriculum. The minutes of the meetings was approved and passed by the members of the academic council. Dr.N.Aruldoss asked for a clarification about redundancy in the communicative English course offered by the life education department with the communicative English course offered by the English department. In response, Rev.Dr.K.A.Maria Arockiaraj SDB, the Additional Principal mentioned that there may be some overlapping in the content, but only to reinforce the communicative skills of the students. Dr.Bhusan D.Sudhakar suggested that the technical skill courses offered by the department of life education can be extended as a certificate course to the Higher Secondary Students of the neighborhood.

Department of Tamil (Language – Part I)

Dr.F.Sagayaraj Francis queried that the Department of English have presented Aims & Objectives as well as the course outcomes for all the courses, and sought for the explanation. In response, Mr.N.Aruldoss responded that this is done, as per the draft template by UGC. Dr.F.Sagayaraj Francis suggested keeping the template as simple as possible. Dr.R.Murali asked for a clarification regarding the programme specific outcomes specified for the Language Courses. Rev.Dr.K.A.Maria Arockiaraj SDB, responded that the board has listed the programme specific outcomes expected from the language courses across programmes. Dr.D.Leslin suggested having a common understanding about the number of items in the programme specific outcomes and course outcomes. Dr.S.Sagayaraj mentioned that in CDC a common guideline to have 5 or 6 programme specific outcomes and 6 course outcomes was accepted. Dr.L.Ravi suggested that series of workshops on Outcome Based Education(OBE) framework should be arranged for the faculty for better adaptation of OBE.

certificate, diploma and degree programmes. Dr.L.Ravi suggested that the college should be ready to implement New Educational Policy as per the government's directions. Rev.Dr.Charles Lasrado SJ, suggested organizing a workshop to train the faculty on Outcome Based Education (OBE) framework.

Dr.Babu Janarthanan, wanted to know about the type of the course, and Dr.K.A.Maria John Joseph, the chairman of the board responded that the course is a Skill Elective paper.

Dr.F.Sagayaraj Francis asked for the clarification with regard to the internship, and Rev.Dr.D.Maria Antony Raj SDB responded that, this programme is introduced based on the increasing demand for graduates in civil aviation management, and there are three airports available in the vicinity, where the internship can be carried out. The academic council accepted and approved the syllabi of PGDCAM and directed the Board to apply for affiliation of the programme.
