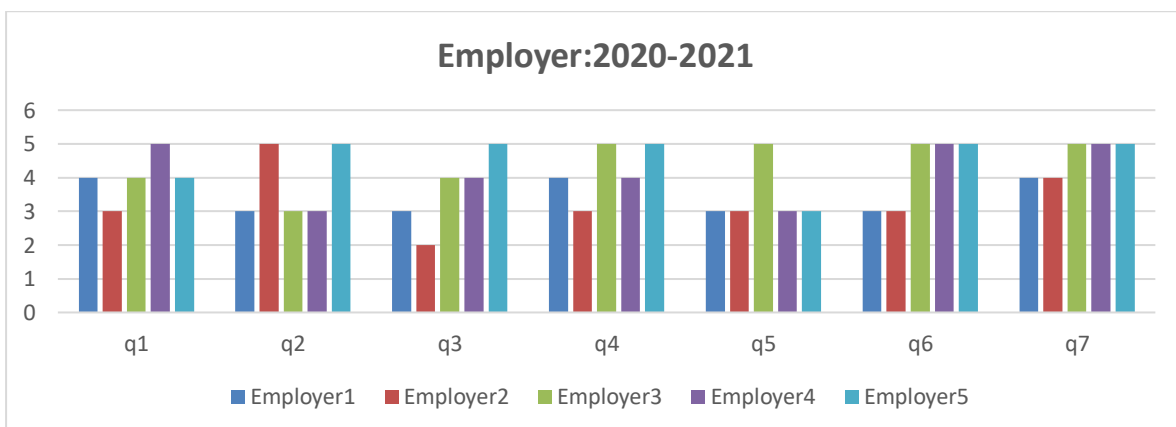

Employers viewed that the curriculum of B.Com (CA) is satisfactory and relevant to theory and practical. However, they expect availability of text book and

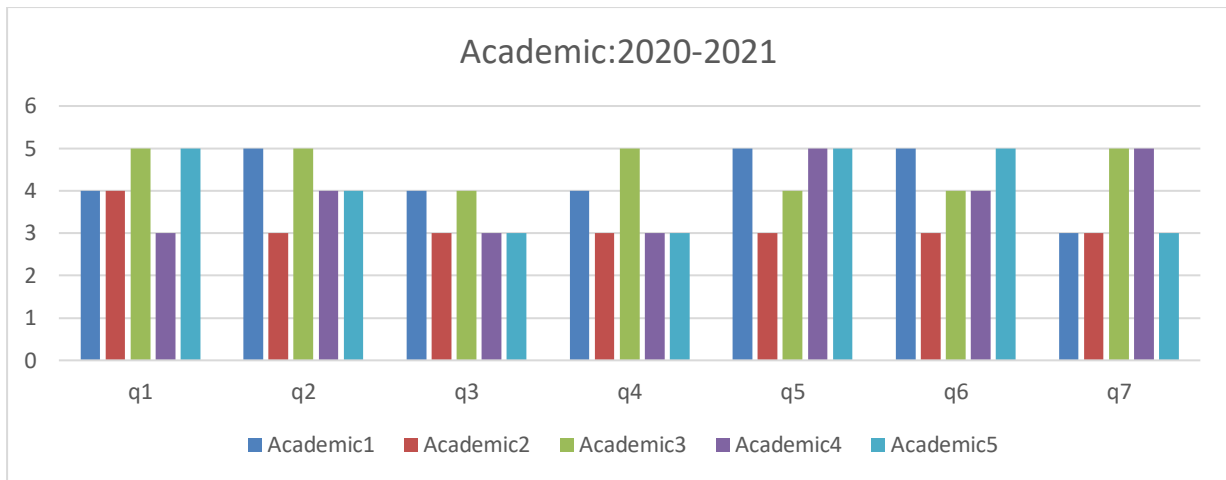
usage of latest technology need to be increased. Most of the employer viewed that follow up of the students, usefulness of tests and assignment are excellent.
